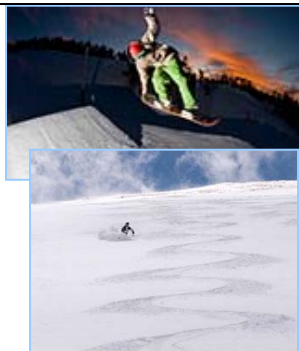

All cancellations/product returns result in a minimum of a \$50/person service charge regardless of the cancellation date.
