**Three Valleys, France** is the largest ski area in the world. It is a gorgeous destination that all skiers/boarders should experience. The beauty is not only in the panoramic views of the Alps, but also in the efficient connections between all of the valleys. The lift system is among the most modern in the world, with over 200 lifts and 386 miles of ski trails, eight ski areas that connect **Brides-Les Bains, Meribel, Courchevel, Val Thorens, La Tania, Les Menuires, St Martin De Belleville, Orelle**. Three Valleys hosted many of the 1996 Olympic ski events and hockey games. One ski lift pass is good for all areas. A skier/boarder would need at least a month to experience everything Three Valleys has to offer! Meribel is the heart of the Three Valleys located between Val Thorens and Courchevel. This village gives skiers/boarders easy access to the entire ski region. Meribel is a modern and well-equipped ski area however; it maintains the charm of an old village in the Savoie area

of France. There are ski trails for all abilities from wide, gentle well-groomed slopes for the beginners, to steep trails with moguls to challenge the experts.

**Hotel Amelie** Located in the center of the main village of Brides Les Bains, the hotel is just a few minutes walk from the gondola that transfers you to the ski area of Meribel in the center of the eight ski areas that make up the Three Valleys (which is the largest ski area in the world). Amelie is a very popular hotel. Happy Time groups have stayed here many times in the past and have always enjoyed the hotel and its excellent staff. The hotel has an indoor and outdoor bar where many skiers stop by for a little hot wine after skiing. The hotel is just across the street from the ski shop where most of the group has rented skis in the past. Our stay includes breakfast and dinner every day. Hearty four course evening meals at the 'Cerisiers' restaurant offering traditional cuisine with wine specialties from the Savoie region. There's often a lively ambience in the hotel bar where guests can enjoy happy hour, an opportunity to discuss their day and plan for the next day's adventures.
